25/18 Apologies

Apologies were received from; Sue Hartley, Gill Oxley, Maddy King, John Perkin and Graham Brearley

26/18 Minutes of previous meeting

The Minutes of the meeting held on July 17th were approved as a correct record

27/18 Air Monitoring

Stephen Davies advised the group that the NO₂ diffusion tubes had been installed at 7 sites. The two particulate matter monitors, for Hardwicke and Haresfield respectively, had been ordered but some parts proved to be missing, leading to a slight delay in the installation. Discussions had been held with the two parish councils about installations and agreements had been reached.

Dave Jackson reported that the supplier would provide a set up instruction when ready to install. The NO2 monitors were in place from the 5th September and it was likely that reports would be on a monthly basis.

28/18 Construction Plan Update

Stacey Wright presented the look ahead reports; the fire water tank had been installed, pressure testing on the boiler would commence on September 21st and the weighbridge and gate house was due for completion in October.
